## ORDER APPROVING COMPLIANCE TARIFFS

Issue Date: October 23, 2020

Effective Date: November 4, 2020

On August 26, 2020, the Commission issued its Report and Order (Order) granting Confluence Rivers Utility Operating Company, Inc. (Confluence) authority to purchase Port Perry Service Company, which provides both water and sewer service in areas of unincorporated Perry County. The Order required Confluence to file Adoption Notice tariff sheets within ten days after closing on the purchase, which were filed on October 5, 2020. The tariff sheets have a proposed effective date of November 4, 2020.

On October 16, 2020, the Staff of the Missouri Public Service Commission (Staff) filed an expedited recommendation affirming that the tariff sheets comply with the Commission's Order. The Commission directed the filing of any responses to Staff's recommendation or the tariff sheets. No responses or objections were received, thus the Commission will take up Confluence's compliance tariff sheets unopposed.

Upon reviewing the pleadings, the Commission finds Confluence's proposed tariff adoption notices comply with the Commission's August 26, 2020, Order and will approve them. To accommodate Confluence's chosen tariff effective date, the Commission will make this order effective in less than 30 days, and will approve the tariff adoption notices to become effective on November 4, 2020.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff adoption notices filed on October 5, 2020, by Confluence, and assigned Tariff Nos. YS-2021-0094 and YW-2021-0093 are approved to become effective on November 4, 2020.
2. This order shall be effective on November 4, 2020.
3. This file shall close on November 5, 2020.


