On May 6, 2020, Evergy Metro Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West applied for an accounting authority order to govern costs and financial impacts associated with the COVID-19 pandemic.

On October 28, 2020, the Commission issued its *Order Setting Hearing Date and Resuming Procedural Schedule*, setting an evidentiary hearing on November 12-13, 2020, to be conducted by telephone and video conference.
