STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, in response to the Commission's February 27, 2025, *Order Opening an Investigation*, and for its *Status Report* states as follows:

- 1. On February 27, 2025, Commission issued its *Order Opening an Investigation* directing Staff to conduct an investigation of all of the Liberty Utility companies operating in the state of Missouri, noting that the Commission has had numerous inquiries, complaints, comments, and testimony about issues with Liberty Utilities' billing and customer service.¹ The Commission has ordered Staff to file a report of its investigation when it has completed its investigation, and to file status reports every three months beginning on April 30, 2025, informing the Commission of the status of its investigation and stating when it expects to file its final investigation report.
- 2. On April 30, 2025, Staff filed its *Status Report* updating the Commission on the status of its investigation, and indicating that, at that time, it did not have an estimated date by which it would be able to submit its report.

- 3. Since Staff's April 30th Status Report, Staff has taken the following actions:
 - On June 6, 2025, Staff performed an on-site visit of Empire Electric's²
 meter shop;
 - During the week of June 9. 2025, Staff, in conjunction with the Office of the Public Counsel (OPC) and Liberty Utilities, conducted four Town Hall Meetings (June 10th at Aurora, MO; June 11th at Branson, MO; June 11th at Ozark, MO; and June 12th at Joplin, MO). These Town Hall Meetings were well attended and proved useful in discovering additional potential issues requiring further discovery and discussion with Liberty Utilities personnel;³
 - On June 12, 2025, Staff performed on-site visits of Liberty Utilities' Billing
 Department and met with individuals capable of discussing its conversion to
 its new billing system (SAP).
 - Staff, Liberty Utilities, and OPC have continued to meet monthly⁴ to discuss Liberty Utilities' past, present, and future status of its customer service and billing practices.
 - Staff continues to conduct discovery. Since its April 30, 2025, Status Report
 Staff has issued over 75 additional data requests.
- 4. As ordered in the Commission's February 27, 2025, *Order Opening an Investigation*, Staff will submit a report of its investigation when it has completed its investigation. At this time, Staff hopes to complete its investigation and submit its report

to the Commission by September 30, 2025. Should Staff be unable to meet its anticipated submission date, Staff will file a pleading updating the Commission on the status of its investigation prior to that date.
