On July 30, 2025, The Empire District Electric Company d/b/a Liberty filed a tariff sheet, Tracking No. JE-2026-0010, to update the Renewable Energy Purchase Program rate. Liberty's tariff sheet bears an effective date of September 1, 2025. The Commission will direct its Staff to examine the tariff sheet and file a recommendation as to whether it should be approved. The Commission will also set a deadline for any other comments about Liberty's tariff sheet.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about Liberty's tariff sheet no later than August 11, 2025.
2. Any other comments about Liberty's tariff sheet must be filed no later than August 11, 2025.
3. This order is effective when issued.
