**ORDER GRANTING MGE'S MOTION  
FOR LEAVE TO WITHDRAW AS INTERVENOR**

This order grants Missouri Gas Energy's motion to withdraw.

On June 6, 2001, MGE filed its motion for leave to withdraw as intervenor. MGE stated that its interest in this case was initially created by the Staff's motion for an order permitting the use of information because Staff was proposing to use data on the cost and volume of natural gas that had been provided by MGE on a confidential basis. The subsequent withdrawal, however, of this information under the order issued by the Commission on May 24, 2001, left MGE without a direct interest.

Thus, MGE requested that the Commission grant its motion for leave to withdraw as an intervenor. The Commission will grant that motion.

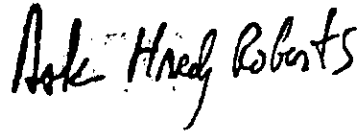
**IT IS THEREFORE ORDERED:**
