On June 11, 2025, Union Electric Company d/b/a Ameren Missouri filed its Program Year 2024 (PY2024) annual evaluation, measurement, and verification (EM&V) reports. The reports, compiled by Ameren Missouri's third-party contractor, ADM Associates, Inc., assessed the electric energy and demand savings of Ameren Missouri's energy efficiency portfolio for PY2024.

Evergreen Economics, contracted by the Commission to conduct an independent audit of the EM&V reports, filed its *Independent EM&V Audit of the Ameren Missouri PY2024 Program Evaluations* on July 14, 2025.

No comments or change requests were filed regarding either report. Therefore, the Commission accepts the EM&V and audit reports for PY2024.
