PROPOSED LIST OF WITNESSES AND ORDER OF CROSS-EXAMINATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), Office of the Public Counsel, and Laclede Gas Company, and respectfully state as follows:

1. On November 17, 2000, Laclede Gas Company ("Laclede") filed with the Missouri Public Service Commission ("Commission") tariff sheets setting forth modifications to its Gas Supply Incentive Program, which was scheduled to expire on September 30, 2001.

2. Subsequently, in response to the Staff's Motion to Suspend the tariff sheets, the Commission established this case to consider the future of the Gas Supply Incentive Program ("GSIP"). As part of this case, the Commission has ordered the parties to file a list of witnesses to appear at the hearing and establish the order of cross-examination.

3. The parties signed below have agreed to file a common pleading setting forth the requested information. As intervenors have not prefiled testimony, there does not appear to be any purpose in incorporating a place for a primary case by intervenors. The parties propose the following guidelines for the hearing:

- A. Each party will present its entire case, addressing all issues, before the next party begins. Thus, it is impossible to determine the exact date and time a witness will be called.

B. The parties propose to put forth their cases, and witnesses, in the following order:

C. The parties propose the following order for cross-examination:

For Laclede Gas Company witnesses: first intervenors, then Office of the Public Counsel, then Staff.


For Office of the Public Counsel witnesses: first Staff, then intervenors, then Laclede Gas Company.


