## RESPONSE TO STAFF MOTION TO CANCEL REGISTRATION

COMES NOW Cloudli Communications Inc., successor in interest to ConnectMe, LLC, by and through counsel, and files this Response to the *Motion* to Cancel Registration filed by the Staff of the Commission on July 22, 2025.

Cloudli urges the Public Service Commission of Missouri not to cancel ConnectMe's IVoIP Registration at this time, as explained more fully below. Cloudli, as successor in interest to ConnectMe, seeks to continue to serve Missouri customers and to fully comply with MoPSC regulatory requirements. Cloudli is in the process of updating its regulatory operations to obviate the issues that have led to Staff's *Motion* of July 22, 2025.

Cloudli acquired the Missouri assets and customers of ConnectMe LLC during the year 2022. The transaction did not require approval by the Missouri Public Service Commission. Regrettably, however, Cloudli failed to secure its own Missoouri IVoIP Registration at that time. As a result, Cloudli has not had company contacts of its own in the Commission's Electronic Filing and Information System (EFIS), which has made it difficult for Staff to reach the Company concerning such matters as annual reports, statements of revenue and assessments. Cloudli regrets, and apologizes to the Commission for, this failure on its part.

Cloudli paid ConnectMe's MoPSC assessments for 2024 and 2025 during the early spring of 2025, and is in the process of arranging payment of the 2026 assessment referred to in the *Motion*. Cloudli is also in the process of completing and filing the revenue statements and annual reports for 2022, 2023 and 2024 referenced in the *Motion*, and has updated EFIS contacts.

Cloudli has also filed its own application for IVoIP Registration contemporaneously with this Response, in MoPSC Case No. DD-2026-0032.

Cloudli submits that no hearing is needed in this matter. Cloudli submits that once its IVoIP Registration is granted by the Commission, the IVoIP Registration of ConnectMe LLC may be cancelled.,

WHEREFORE, Cloudli Communications Inc. respectfully requests that the Commission not cancel the Missouri IVoIP Registration of ConnectMe LLC until Cloudli has been granted Missouri IVoIP Registration by the Commission.
