**JOINT STATUS UPDATE**

**COME NOW** Spire Missouri Inc. ("Spire Missouri" or "Company"), Staff of the Missouri Public Service Commission ("Staff"), the Office of Public Counsel ("OPC"), Consumers Council of Missouri ("CCM"), Missouri Industrial Energy Consumers ("MIEC"), Missouri School Boards' Association ("MSBA"), and Midwest Energy Consumers Group ("MECG") (collectively, the "Parties") and for their Joint Status Update, state the following to the Missouri Public Service Commission ("Commission"):

1. The Parties have agreed on a stipulation and agreement document that includes a \$210 million base revenue increase and resolves all issues in this case, except for the revenue allocation and rate design.
2. The Parties have been working on revenue allocation and rate design, but due to scheduling issues, Parties have been unable to reach final agreement on those two items.
3. The Parties agree that they will continue working towards finalizing a full stipulation and agreement over the weekend and into Monday.
4. The Parties agree that on Monday, the Parties will file a full stipulation, or, in the alternative, file a partial stipulation and a status update on revenue allocation and rate design.
5. The Parties jointly request that the Commission issue an order directing the Parties file a full stipulation Monday or, in the alternative, file a partial stipulation on all items except revenue allocation and rate design, and a status update on the revenue allocation and rate

design on Monday.

**WHEREFORE**, the Parties respectfully request that the Commission issue an order directing the Parties file a full stipulation Monday or, in the alternative, file a partial stipulation on all items except revenue allocation and rate design, and a status update on the revenue allocation issue on Monday.
