## ORDER DIRECTING RESPONSES

Issue Date: August 4, 2025

Effective Date: August 4, 2025

On July 1, 2025, Spire Missouri Inc. (Spire Missouri) filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet, assigned Tracking Number JG-2026-0001. Spire Missouri projected that the changes to the WNAR tariff sheet would decrease the monthly bill of the average residential customer. The tariff sheet bears a September 1, 2025, effective date.

The Staff of the Commission (Staff) filed its recommendation, which was for approval. In response, the Office of the Public Counsel (OPC) filed *Response to Application to Update Weather Normalization Adjustment Rider for Spire East and Spire West* (Response). The Response alleges that the proposed tariff sheet would result in a WNAR above a previously set rate limit.

The Commission will direct Spire Missouri to respond. The Commission will also direct Staff to respond.

### THE COMMISSION ORDERS THAT:

1. No later than August 11, 2025, Spire Missouri and Staff shall file their respective replies to OPC's Response.
2. This order is effective when issued.
