ORDER AMENDING THE RECORD

On July 16, 2025, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) and Missouri-American Water Company (MAWC) filed their *Motion to Correct Transcript*. The motion stated that witness Stephen Kadyk misspoke at the evidentiary hearing regarding what specific MAWC systems that are currently subject to an administrative order on consent. The Commission treated the motion as a motion to amend the record and shortened the time for responses. No responses were received.

The Commission will grant the motion and amend the record to reflect that Kadyk's answer to what systems had compliance issues and were subject to an Administrative Order on Consent with the Department of Natural Resources are "Stoney Creek and the Highlands" and not "Golden Pond and the Highlands".

THE COMMISSION ORDERS THAT:

1. Confluence Rivers and MAWC's motion to amend the record is granted.

The record is amended as set forth in the body of this order.
