NOTICE OF EXPIRATION OF VIDEO SERVICE AUTHORITY

Issue Date: August 5, 2025

On August 4, 2025, Citizens Cablevision, Inc. notified the Commission that it has ceased to provide video service, has no video service customers, and seeks to cancel its video service authority. The Commission granted video service authority to Citizens Cablevision in Case No. KA-2010-0369.

Under Section 67.2685, RSMo (2016), Citizens Cablevision's service authorization expired upon notice to the Commission that it will cease to provide video service under that authorization. The Commission acknowledges receipt of notice by Citizens Cablevision that it has ceased to provide video service. The authorization has expired by operation of law and no further action by the Commission is required. This case may be closed.
