## CERTIFICATE TO PROVIDE TELECOMMUNICATIONS SERVICE

On October 28, 2020, Northeast Missouri Rural Telephone Company filed an application for authorization to provide basic local and non-switched local telecommunications service in exchanges in the cities of Kirksville and Milan in the State of Missouri, as permitted by Sections 392.611.4 and 392.550, RSMo (2016).

The Commission has reviewed the application filed by Northeast Missouri Rural Telephone Company and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo (2016). Pursuant to 392.550.3, RSMo (2016), this order shall be effective in less than thirty days.

### THE COMMISSION ORDERS THAT:

1. Northeast Missouri Rural Telephone Company is granted authority to provide basic local telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above.

2. Northeast Missouri Rural Telephone Company is granted authority to provide non-switched local telecommunications service in the exchanges set forth in the affidavit attached to the application and restated above.

3. This order shall become effective on November 27, 2020.

4. This file shall close on November 30, 2020.
