On October 30, 2020, Spire Missouri Inc. d/b/a Spire filed tariff sheets to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment for its Spire Missouri East Operating Unit, and Spire Missouri West Operating Unit. The tariff sheets bear an effective date of November 16, 2020.
