## **AMENDED ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR ANY RESPONSES TO TARIFF SHEET**

On October 30, 2020, Spire Missouri Inc. d/b/a Spire (East) filed a tariff sheet to reflect changes in the company's Purchased Gas Adjustment clause and Actual Cost Adjustment. The tariff sheet bears an effective date of November 16, 2020.

In consideration of the effective date of the tariff sheet, the Commission will direct the Staff of the Missouri Public Service Commission to file a recommendation on an expedited schedule. The Commission will also establish a deadline for any responses to the tariff sheet.

1. The Commission's Staff shall file a recommendation concerning the above-referenced tariff sheet no later than November 9, 2020.
2. Any other comments or recommendations concerning Spire East's tariff sheet shall be filed no later than November 9, 2020.
