On September 21, 2020, Russ Coleman filed a complaint with the Missouri Public Service Commission (Commission) against Evergy Metro, Inc. d/b/a Evergy Missouri Metro. The Commission directed a report from the Staff of the Missouri Public Service Commission (Staff) no later than November 9, 2020. On November 3, 2020, Staff filed a request for an extension of time to December 10, 2020.

Counsel for Staff represented that upon inquiry, no parties object to this request. Based on the representation of counsel, the Commission will consider the request unopposed.

The Commission finds the unopposed motion reasonable, and will grant it.


