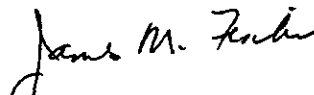

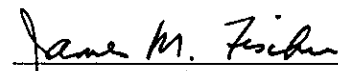

MOTION FOR ORDER OF ADMISSION *PRO HAC VICE*

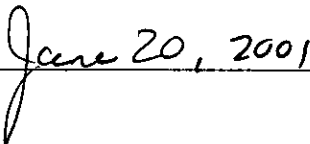

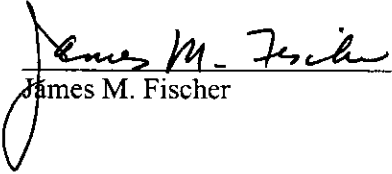
