ORDER DIRECTING EXPEDITED STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 6, 2020, Liberty Utilities (Midstates Natural Gas) Corp d/b/a Liberty Utilities filed tariff sheets to reflect changes in the company's Regular Purchased Gas Adjustment and Actual Cost Adjustment Factors. The tariff sheets bear an effective date of December 6, 2020. Liberty Utilities has not requested expedited approval of its tariff, but it filed a motion for variance from a provision of its tariff that requires its winter PGA/ACA tariff to be filed by November 4.

The Commission will direct the Staff of the Commission to file a recommendation, and will establish a deadline for any other entity to file a response to the tariff sheets.

THE COMMISSION ORDERS THAT:

1. No later than November 16, 2020, the Staff of the Commission shall file a recommendation with regard to the above-referenced tariff sheets and the motion for variance.
2. Any other entity wishing to comment on the tariff sheets or the motion for variance shall do so no later than November 16, 2020.
3. This order shall be effective when issued.
