On October 22, 2020,¹ Missouri-American Water Company filed an Application and Motion for Waiver (Application). On October 23, the Commission issued its Order Directing Notice, Setting Date for Intervention, and Ordering Staff Recommendation. Therein the Commission ordered the Commission Staff (Staff) to suggest a date by which it could file a recommendation on the Application no later than November 6. On November 6, the Staff filed a Proposed Filing Date stating it expected to file a recommendation on the Application no later than February 4, 2021. The Commission will order Staff to do so.

1. The Commission Staff shall file its recommendation in this case no later than February 4, 2021.
2. This order shall be effective when issued.
