On November 5, 2020, Union Electric Company d/b/a Ameren Missouri filed its application for acceptance of its filing of cost estimates for Callaway Energy Center decommissioning. Before acting on Ameren Missouri's application, the Commission will direct its Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Staff shall file a recommendation regarding Union Electric Company d/b/a Ameren Missouri's Application no later than February 9, 2020. Staff may request additional time if it is unable to offer its recommendation by that date.
2. This order shall become effective upon issuance.
