ORDER DIRECTING STAFF TO FILE RECOMMENDATION

On November 4, 2020, The Raytown Water Company (Raytown) submitted an application requesting authority to issue preferred stock in a principal sum not to exceed \$5 million. The proceeds will be used for the construction of new water main valves and fire hydrants.

Raytown's application does not comply with the sixty day notice requirement of Commission Rule 20 CSR 4240-4.017(1), nor does it request a waiver of that requirement. The Commission will allow Raytown to supplement its application with a request for waiver of the sixty day notice requirement.

The Commission will also direct the Staff of the Commission to file a response to Raytown's application. If Staff finds it requires more time to prepare a recommendation, it may request additional time.

THE COMMISSION ORDERS THAT:

1. No later than December 21, 2020, Staff shall file a recommendation regarding Raytown's application.
2. No later than November 19, 2020, Raytown shall submit a request for waiver of the sixty day notice of case filing requirement in 20 CSR 4240-4.017(1).

3. This order shall be effective when issued.
