### ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On September 30, 2020, Spire Missouri Inc. d/b/a Spire filed tariffs that would modify its Commercial and Industrial rebate program language. Staff filed a motion to suspend those tariffs, which the Commission granted. The tariffs are suspended until December 30, 2020.

The Commission ordered Staff to file a Recommendation or alternative pleading on November 16, 2020. Staff filed a Request for Extension on November 16, 2020. Staff states that it requests until November 30, 2020 to file its Recommendation so that Staff can receive discovery and so that the parties may continue discussing the tariffs.

The Commission finds the request reasonable, and will grant it.

#### THE COMMISSION ORDERS THAT:

- 1. The Request for Extension filed by Staff is granted.
- 2. The Staff of the Commission shall file its Recommendation or alternative pleading no later than November 30, 2020.
