On October 16, 2020, the Commission issued its Order Directing Notice, Setting Date for Intervention, Consolidating Files, and Ordering Staff Recommendation. The Commission ordered the Commission Staff (Staff), no later than November 15, to suggest a date by which it can file a recommendation on the Application. On November 13, the Staff complied and filed a Status Report stating it intended to file its recommendation no later than February 15, 2021. The Commission will order Staff to do so.

1. The Staff of the Missouri Public Service Commission shall file its recommendation on the Application no later than February 15, 2021.
2. This order shall be effective when issued.
