ORDER DIRECTING EXPEDITED RESPONSE

On October 16, 2020, Spire Missouri Inc. d/b/a Spire filed a motion to modify the Commission's June 11, 2020 *Order Approving Application for Temporary Waiver and Directing Written Notice*. Spire requested elimination or extension of the requirement that inspections of noncompliant facilities be completed no later than one year after each facility's "delinquent date." Spire also requested the deadline under the order be extended to March 31, 2021. Spire's motion requested expedited treatment.

On November 20, 2020, Staff filed a recommendation that the Commission grant most of Spire's request, with specified conditions, and deny the request regarding the one-year limit. Staff's recommendation advises that Spire no longer seeks elimination or extension of the one-year limit, based on Spire's response to a data request.

To facilitate expedited review of Spire's motion, the Commission will direct Spire to respond to Staff's recommendation and will establish a deadline for response from any other party. Spire's response shall specify whether it has withdrawn its request in regard to the one-year limit on noncompliance.

THE COMMISSION ORDERS THAT:

1. No later than November 24, 2020, Spire shall file a response to *Staff Recommendation*, as described above.
2. Response to *Staff Recommendation* from any other party shall be filed no later than November 24, 2020.
3. This order shall be effective when issued.
