Filed with this letter is a cover letter from Veolia's Vice President and General Manager Dan C. Dennis, with is accompanied by tariff sheets consisting of rate schedules designed to increase Veolia's base gross annual revenues by approximately \$1,379,000, or 19 percent, exclusive of applicable gross receipts, sales, franchise or occupational fees or taxes. The proposed tariff sheets bear a date of issue of April 22, 2011, and an effective date of May 22, 2011. Also provided for filing are tariff sheets consisting of revisions to Veolia's general rules and regulations.

The test year used Veolia is a calendar 2010 test year, recognizing identifiable known and measurable changes generally through the first quarter of 2011, plus the recognition of a former customer that has recently returned to Veolia's system, as discussed in the Direct Testimony of Steve C. Carver.

Included with this letter and also in the Direct Testimony and Schedules of Daniel C. Dennis is the information required by 4 CSR 240-3.030(3)(B), as follows:
