#### ORDER AND NOTICE

On January 16, 2025, Jim Moriarty filed a complaint against Missouri-American Water Company (MAWC). On July 28, 2025, a prehearing conference was held with the Complainant, Staff Counsel and MAWC. During that conference, Missouri American Water Company requested that one of their witnesses appear remotely, and said that they had a local witness available, if remote testimony was not an option. The Commission will allow the witness to appear remotely by Web Ex, as long as MAWC can work with the Commission's technical staff to facilitate the Web Ex call. Missouri-American Water Company must also have a witness available at the hearing to provide testimony if remote access is unavailable.

In addition, the Commission will order that live rebuttal testimony will be allowed at the hearing.

#### THE COMMISSION ORDERS THAT:

1. The Commission will allow testimony of Missouri-American Water Company's witness via Web Ex at the hearing and will work with the technical staff of the

Commission to facilitate the testimony. Missouri American Water Company will have a local witness available at the hearing in the case of technical difficulties. The Commission sent parties the information needed to access WebEx for the conference via email.

- 2. Rebuttal testimony shall be allowed at the hearing.
- 3. This order shall be effective when issued.
