**MISSOURI-AMERICAN WATER COMPANY’S
REQUEST FOR MEDIATION IN LIEU OF FILING AN ANSWER**

COMES NOW the Respondent, Missouri-American Water Company (“MAWC” or “Company”), pursuant to 20 C.S.R. 4240-2.125(2), and for its *Request for Mediation in Lieu of Filing an Answer*, respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. On July 10, 2025, Edwin Mahr (“Complainant” or “Ms. Mahr”) filed a complaint with the Commission.
2. On July 11, 2025, the Commission issued *Order Giving Notice of Contested Case and Directing Answer to Complaint* giving the Company until August 10, 2025, to file its answer or request for mediation. This filing complies with that Order.¹
3. MAWC believes this matter is appropriate for mediation and therefore requests the Commission appoint a presiding officer to this matter to mediate the dispute between Complainant and MAWQC, pursuant to 20 C.S.R. 4240-2.0125(2)(B).
4. MAWC further requests that the Commission toll the timeline in this case pending completion of the mediation process, pursuant to 20 C.S.R. 4240-2.125(2)(C).

Wherefore, MAWC requests that the Commission accept this Request for Mediation in Lieu of Filing an Answer and to toll all of the time limitations in this matter until completion of the mediation process and any further relief that is just and proper under the circumstance.
