STAFF RECOMMENDATION TO APPROVE TARIFF SHEETS

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Tariff Sheets*, and states the following in support:

1. On July 16, 2025, the Commission issued an Order Approving Stipulation and Agreement ("Order"), and the Commission ordered Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "the Company") to file tariff sheets that are in compliance with the Stipulation and Agreement and this Order on or before July 28, 2025. The Order further ordered Staff to file its recommendation regarding the compliance tariffs no later than August 8, 2025.

2. On July 28, 2025, Ameren Missouri filed its tariff revisions under JG-2026-0009, along with its accompanying tariff filing letter. In its letter, Ameren Missouri stated the tariff sheets were intended to reflect the Commission's *Order*.

3. On July 29, 2025, Staff and Ameren Missouri had discussions in regards to potential issues with a couple of the tariff sheets filed in Tracking No. JG-2026-0009, and Ameren Missouri indicated it would address those issues with substitute tariff sheets.

4. On July 31, 2025, Ameren Missouri filed tariff revisions under Tracking No. JG-2026-0013, along with its accompanying tariff filing letter. In its letter, Ameren Missouri stated these revisions were for the Residential Pay As You Save Program and Co-Delivery Program for Income Eligible Customers, which were proposed in the rebuttal testimony of Ameren Missouri witness Shelly Harmon.

5. On August 5, 2025, Ameren Missouri filed substitute tariff sheets 13 and 16.2 in tariff Tracking No. JG-2026-0009.

6. Staff has reviewed the tariff sheets filed in Tariff Tracking Nos. JG-2026-0009 and JG-2026-0013 on July 28, 2025, July 31, 2025, and August 5, 2025, respectively. Staff recommends the Commission approve the tariff sheets as filed on July 28, 2025 (with two as substituted on August 5, 2025) and July 31, 2025, with effective dates of September 1, 2025.

7. This pleading is verified by the affidavits of Michael Abbott, David Sommerer, Melissa Reynolds, and Keri Roth, which are incorporated by reference herein.

WHEREFORE, for the reasons stated above, Staff recommends the Commission issue an order approving the following tariff sheets filed in this matter, Tariff Tracking No. JG-2026-0009, on July 28, 2025 and as substituted on August 5, 2025, with an effective date of no later than September 1, 2025; and tariff sheets filed in Tracking No. JG-2026-0013 on July 31, 2025, with an effective date of September 1, 2025:
