ORDER GRANTING VARIANCE

Issue Date: August 11, 2025 Effective Date: September 10, 2025

On July 18, 2025, Union Electric Company d/b/a Ameren Missouri filed a Request for Variance. Ameren Missouri stated that it recently discovered it inadvertently neglected to make some required filings as agreed upon in a Stipulation from this case.¹

Paragraph 6 of the Stipulation required Ameren Missouri agreed to provide the following information, on a quarterly basis, for as long as the program is designated as experimental: 1) the number of customer applications for new residential service made to Ameren Missouri, 2) the number of those applications that result in a requirement for a deposit due to the result of an EAER Score, and 3) the amount of each deposit required. Ameren Missouri states that it has corrected its oversight, and it asks for a variance from the Stipulation.

The Staff of the Commission (Staff) to filed a Recommendation on August 2, 2025, stating that it had no objection to the variance. No other responses were received.

The Commission finds good cause to grant the requested variance.
