ORDER APPROVING TARIFF

Issue Date: August 11, 2025

Effective Date: September 1, 2025

On July 28, 2025, Union Electric Company d/b/a Ameren Missouri filed Tracking No. JG-2026-0009. Ameren Missouri filed the tariff to implement new rates as permitted by the Commission's July 16, 2025 Order Approving Stipulation and Agreement (Order). That Order approved a stipulation which, among other things, allowed Ameren Missouri to file a compliance tariff bearing an effective date of September 1, 2025. Ameren Missouri later filed Tracking No. JG-2026-0013, and also filed substitute tariff sheets for Tracking No. JG-2026-0009.

The Commission's Staff filed a Recommendation on August 8, 2025, stating that the Commission should approve the tariff. No other responses were received.

The Commission has reviewed the tariff and Staff's recommendation. Based on these filings, the Commission finds that the tariffs comply with the Order.

The Commission approves the tariffs as ordered below. As the tariff is unopposed, and so that this tariff may go into effect expeditiously on the

requested effective date, the Commission will make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Tracking No. JG-2026-0009, submitted on July 28, 2025, and substituted on August 5, 2025, is approved to become effective on September 1, 2025.
2. Tracking No. JG-2026-0013, submitted on July 31, 2025, is approved to become effective on September 1, 2025.
3. This order shall become effective on September 1, 2025.
