ORDER CANCELLING REGISTRATION

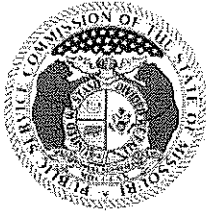

On July 11, 2025, Fonality, Inc. filed a letter notifying the Commission that it no longer wished to retain its registration to provide Interconnected Voice over Internet Protocol (VoIP) services in Missouri. The letter states that Fonality is ceasing to exist as an VoIP provider due to it being consolidated into Sangoma US Inc., its parent company. The Commission granted Fonality its VoIP registration in the State of Missouri in Case No. DA-2019-0322.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority or registration by filing a letter signed by the company's official that identifies when and which certificate, registration, and any applicable tariff to cancel. Based on the request of Fonality, the Commission finds that the VoIP registration granted to it shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Fonality, Inc. in Case Number DA-2019-0322, is cancelled.
2. This order shall become effective on August 1, 2025.
3. This case may be closed on August 2, 2025.


