ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On October 20, 2020, a joint application was filed with the Missouri Public Service Commission requesting either that the Commission approve an acquisition, or that the Commission find it lacks jurisdiction over the matter. The Commission directed the Staff of the Missouri Public Service Commission (Staff) to respond with a recommendation or request for additional time no later than November 23, 2020. On November 23, 2020, Staff filed a request for an extension of time to December 23, 2020.¹

Staff cited the transaction's complexity and need to further investigate the transaction as grounds for an extension of time. Staff also cited a recent information gathering conference call held just prior to its request.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time to file its recommendation is granted.

Staff shall submit its recommendation no later than December 23, 2020.
