**ORDER SUSPENDING TARIFF**

On October 27, 2020, Union Electric Company d/b/a Ameren Missouri filed its Application, Request for Variances, and Request for Accounting Authority along with two tariff sheets designed to implement an electrification pilot program. The tariff sheets bear an effective date of November 30, 2020. The Commission ordered its Staff to file a pleading explaining when it will be able to file its recommendation about Ameren Missouri's application and tariff sheets, and to recommend whether, and for how long, to suspend the tariff sheets.

On November 19, 2020, Staff filed a status report stating it is in discussion with the parties regarding a procedural schedule and hopes to have the schedule filed within the next week. Staff recommends suspending the tariff sheets ninety days.

The Commission will suspend the tariff sheets.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheets assigned Tracking No. YE-2021-0103 are suspended until February 22, 2021.

2. This order shall be effective when issued.
