ORDER GRANTING INTERVENTION

On September 8, 2020, the Commission opened these files at the request of Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West for them to file their 2021 Triennial Integrated Resource Plans on April 1, 2021.

On November 18, 2020, the Commission received intervention requests from Consumers Council of Missouri and AARP. More than ten days have elapsed since those applications were filed, and no party has objected. Thus, the Commission will take up those applications unopposed.¹

The Commission finds that the interests of these applicants differ from those of the general public and may be adversely affected by a final order arising from this case. Furthermore, the Commission finds that allowing the applicants to intervene will serve the public interest. Therefore, the Commission will grant the applications to intervene.
