ORDER DIRECTING STAFF TO FILE AN EXPEDITED RECOMMENDATION AND SETTING TIME FOR RESPONSES

On November 25, 2020, Evergy Missouri Metro and Evergy Missouri West (Evergy) filed requests to revise their Technical Resource Manuals (TRMs). Evergy wants to make changes to its TRMs to incorporate additional final Evaluation, Measurement, and Verification for program year four of its Missouri Energy Efficiency Investment Act Cycle 2. Evergy states that the revisions were provided to Commission's Staff (Staff) on November 20, 2020. Evergy requests that its TRMs be approved to be effective January 1, 2021, to align program tracking data and program evaluation data.

The Commission will order Staff to file an expedited recommendation regarding Evergy's proposed TRM revisions, and shall set a time for any responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding Evergy's proposed TRM revisions no later than December 9, 2020.
2. Any responses to Staff's recommendation or Evergy's TRMs shall be filed no later than December 11, 2020.

3. This order is effective when issued.
