## ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On September 1, 2020, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed its application for approval of the accrual and funding of Wolf Creek Generating Station decommissioning costs at current levels. The Commission directed the Staff of the Missouri Public Service Commission (Staff) to respond with a recommendation or request for additional time no later than December 4, 2020. On December 4, 2020, Staff filed a request for an extension of time to January 8, 2021. Counsel for Staff represented that Evergy Missouri Metro is aware of Staff's request and had no objections.

Staff cited its continuing technical analysis in some aspects of the application as grounds for an extension of time. Staff's motion also indicates that as discussions are ongoing, a resolution by Stipulation and Agreement could occur in the proposed extended time frame.

The Commission finds the motion reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time to file its recommendation is granted.

Staff shall submit its recommendation no later than January 8, 2021.

2. This order shall be effective when issued.
