ORDER GRANTING MOTION TO STAY

On July 16, 2025,¹ Complainant Bobby J. Armour filed a formal complaint against Spire Missouri Inc. d/b/a Spire. On July 17, the Commission ordered Spire's Answer be filed by August 15. On July 30, Spire filed a *Motion to Dismiss* for failure to state a claim. The Commission then scheduled a procedural conference for August 20.

On August 13, Spire filed a *Motion to Stay the Order Directing Answer* (Motion) until a decision was made on pending motions and the procedural conference was held. The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Spire's Motion is granted.
2. The Commission order for Spire to file an answer by August 15, 2025 is suspended.
3. The Commission will order a new deadline for Spire to file an answer after the procedural conference.
4. This order is effective when issued.
