On November 20, 2020, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet to comply with the terms of the Commission's November 18, 2020 *Order Granting Variances and Waivers*. The tariff sheet bears an effective date of December 20, 2020.

The Commission directed Staff to file a recommendation and any other party to file responses no later than December 2, 2020. Staff filed its recommendation that the tariff sheet be approved on December 2, 2020. No other responses were received.

After reviewing the tariff sheet and the Staff recommendation, the Commission concludes that Ameren Missouri's tariff sheet complies with the Commission's order and will approve it.

THE COMMISSION ORDERS THAT:

1. Tariff sheet, bearing Tariff No. YE-2021-0120, filed by Union Electric Company d/b/a Ameren Missouri on November 20, 2020, is approved to become effective on December 20, 2020.
