NOTICE OF PROPOSED EXHIBITS AND ORDER DIRECTING FILING OF OBJECTIONS

On December 4, 2020, the Commission conducted an evidentiary hearing in Claude Scott's complaint against Spire Missouri, Inc. d/b/a (Spire). Before the hearing, the Commission directed the parties to disclose proposed exhibits with a filing in the Commission's electronic filing and information system (EFIS). In addition, the Commission directed Spire to deliver to Mr. Scott a copy of Spire's proposed exhibits.

On November 25, 2020, Spire filed in EFIS an exhibit disclosure, which included a letter, dated June 1, 2020, which is addressed to Mr. Scott and signed by Spire employee Elgin Manalang. On December 3, 2020, counsel for Spire filed a statement confirming its efforts to deliver a copy of Spire's exhibit disclosure to Mr. Scott before the hearing.

During the hearing on December 4, 2020, Spire offered the June 1, 2020 letter, to be marked as Exhibit No. 103, to be included in the record of this case. Mr. Scott objected that he did not have a copy of the letter, although Mr. Scott acknowledged receipt of various other documents included in Spire's exhibit disclosure.

Also during the hearing, when a witness for Spire began testifying in regard to Mr. Scott's account as of August 2019, the presiding officer observed that account statements beginning in June 2019 and continuing through January 2020 had been identified as potential exhibits, but a statement for August 2019 had not been submitted by any party. To assist with understanding the witness' testimony, the presiding officer requested Spire file the statement in EFIS after the hearing.

On December 8, 2020, Spire filed in EFIS a copy of a statement addressed to Mr. Scott, with a statement date of August 5, 2019.

The subject documents, which are designated confidential, are attached to this order. The Commission will provide notice of such documents and direct that any objection to admission on the record in this case of the June 1, 2020 letter or the August 5, 2019 account statement be filed no later than December 31, 2020. Documents admitted to the record may be considered by the Commission in making a decision in this case.

THE COMMISSION ORDERS THAT:

1. Any objection to admission of the June 1, 2020 letter to the record in this case shall be filed no later than December 31, 2020.
2. Any objection to admission of the August 5, 2019 account statement to the record in this case shall be filed no later than December 31, 2020.

Submission by mail must be received no later than December 31, 2020, and will be posted to EFIS.

4. The Commission's data center shall mail a copy of this order, with attached documents, to Mr. Scott by U.S. Mail addressed to Mr. Scott's address of record.
