On August 24, 2020, Roeslein Alternative Energy Services, LLC filed an application requesting waiver of compliance with gas odorization required by 20 CSR 4240-40.030(12)(P) in operation of a gas transmission line in Putnam County, Missouri.

Consistent with the Commission's *Order Directing Filing*, Staff filed a recommendation in this matter and recommended the Commission grant Roeslein's waiver request with specified conditions.

The Commission will establish a deadline for any response to the *Staff Recommendation*, filed on December 8, 2020.

1. Any response to *Staff Recommendation*, filed on December 8, 2020, shall be filed no later than December 21, 2020.
2. This order shall be effective when issued.
