On October 28, 2020, Missouri-American Water Company (MAWC) applied for a certificate of convenience and necessity to install, own, acquire, construct, operate, control, manage and maintain a sewer system in and around Taos, Missouri. MAWC requests Commission approval to acquire the City of Taos sewer system.

The Commission ordered its Staff to file, no later than December 10, 2020, a recommendation or a status report indicating when it expects to file a recommendation. Staff filed a status report on December 10, 2020, and advised it continues to gather information about the case. Staff's report indicates review may be extended by ongoing data requests, upcoming holidays and Missouri-American Water Company's rate case in File No. WR-2020-0344. Staff states it intends to file its recommendation no later than February 10, 2021.

The Commission will order Staff's recommendation consistent with Staff's status report.
