On December 11, 2020, a motion to suspend the procedural schedule was filed jointly by all parties. The motion represents that the Office of the Public Counsel, together with Elm Hills Utility Operating Company, Inc., have reached an agreement in principle to resolve all issues in this case. The motion states further that the Staff of the Missouri Public Service Commission does not oppose the agreement, and that the parties intend to formalize this agreement in a filing on December 14, 2020.

The Commission finds the unanimous motion reasonable, and will grant it.
