ORDER APPOINTING MEDIATOR

On September 18, 2020,¹ Louis DeFeo (Complainant) filed a complaint with the Missouri Public Service Commission against Missouri-American Water Company (Company). On October 16, the Company filed an Answer to Complaint and Request for Mediation. On December 9, Complainant sent a communication to the regulatory law judge supporting the Company's request for mediation but asking it not be scheduled until after Respondent provided documents Complainant had requested and after the Commission Staff had filed its report. Also on December 9 the Staff filed its Staff report. The Commission will appoint Judge John Clark as mediator. It will suspend all other activities and toll all time limitations except as to currently pending data requests.

THE COMMISSION ORDERS THAT:

1. The request for mediation is granted.
2. Judge John Clark is appointed mediator.

3. All other actions in the case shall cease and all time limitations shall be tolled except as to currently pending data requests.

4. This Order shall be effective when issued.
