## ORDER PROVIDING FOR CORRECTION TO ADMITTED AND FILED EXHIBITS

Issue Date: December 17, 2020

Effective Date: December 17, 2020

On December 4, 2020, the Commission conducted an evidentiary hearing in Claude Scott's complaint against Spire Missouri, Inc. d/b/a Spire. The hearing was conducted by telephone conference call, also accessible by video via Webex.

Consistent with the Commission's November 12, 2020 procedural order, the parties filed copies of all proposed exhibits in the Commission's electronic filing and information system (EFIS). Mr. Scott's filing was made on December 1, 2020, and Spire's filing was made on November 25, 2020. On December 3, 2020, Spire filed a statement confirming its effort to deliver paper copies of Spire's proposed exhibits to Mr. Scott. The pre-hearing document disclosure enabled the parties and the presiding officer to review proposed exhibits and conduct a hearing by telephone conference.

In addition to the documents identified below, two additional documents – a June 1, 2020 letter and an August 5, 2019 account statement – have been offered by Spire. The June 1, 2020 letter was included in Spire's exhibit disclosure in EFIS on November 25, 2020; Spire filed the August 5, 2019 account statement in EFIS on

December 8, 2020, as requested by the presiding officer. Those proposed exhibits remain subject to potential objection by no later than December 31, 2020, as provided by the Commission's order issued on December 10, 2020.
