## ORDER TO SHOW CAUSE WHY PARTY SHOULD NOT BE DISMISSED

Issue Date: December 18, 2020 Effective Date: December 18, 2020

On September 23, 2020, Rachael Staude and Grand Property Management KC filed a complaint against Every Metro, Inc. d/b/a Evergy Missouri Metro. Only Rachael Staude signed the complaint. Grand Property Management KC is registered with the Missouri Secretary of State as a limited liability corporation (LLC) with Rachael Staude as its President and Registered Agent. The complaint suggests that the disputed accounts are currently, or have been, in the name of Rachael Staude, as an individual, and in the name of Grand Property Management KC.

On September 25, 2020, the Commission issued notice and order setting a time for an answer to the complaint. The Commission also directed its Staff to file a report of its recommendations and investigation of the complaint. On December 8, 2020, Staff filed a motion requesting clarification regarding the potential dismissal of Grand Property Management KC and for a further extension of time until January 5, 2021, to file its report. Staff was granted an extension of time to file its report until January 15, 2021. In its

motion, Staff also indicated that it believes only amounts in the name of Grand Property Management KC are in dispute.

In the September 25, 2020 notice and order, the Commission notified Grand Property Management KC that as a limited liability company it must be represented by an attorney in order to appear at the Commission in a formal complaint. Grand Property Management KC was directed to fix its deficiency no later than October 26, 2020, or be subject to dismissal from the complaint. No attorney has entered its appearance on behalf of Grand Property Management. Therefore, the Commission will direct Grand Property Management to show cause why it should not be dismissed for failure to comply with the Commission's order and Commission Rule 20 CSR 240-2.040(5).

#### THE COMMISSION ORDERS THAT:

- 1. No later than January 12, 2021, Grand Property Management KC shall show cause why it should not be dismissed.
  - 2. This order shall be effective when issued.
