## ORDER APPROVING COMPLIANCE TARIFFS

On November 4, 2020, the Commission issued its Order Approving Proposed Tariff Wording (Wording Order) regarding the three tariff revisions submitted by Evergy Metro, Inc. as part of its Customer Forward Program. No tariff sheets were submitted as part of its application; rather, Evergy Metro, Inc. requested approval of the tariff wording prior to filing revised tariffs in order to allow the wording revisions to undergo a customer testing program.

On November 23, 2020, Evergy Metro, Inc. submitted tariffs in compliance with the Commission's Wording Order. The tariff sheets have a proposed effective date of January 18, 2021.

On December 14, 2020, the Staff of the Missouri Public Service Commission (Staff) filed its recommendation that the tariff sheets be approved. Per 20 CSR 4240-2.080(13), the Commission allowed for the filing of any responses to Staff's recommendation or the proposed tariff sheets. No responses or objections were received, thus the Commission will take up Evergy Metro, Inc.'s compliance tariff sheets unopposed.

Upon reviewing the pleadings, the Commission finds Every Metro, Inc.'s proposed tariff sheets comply with the Commission's Wording Order and will approve

them. To accommodate Evergy Metro, Inc.'s chosen tariff effective date, the Commission will make this order effective in less than 30 days, and will approve the proposed tariff sheets to become effective on January 18, 2021.

**THE COMMISSION ORDERS THAT:**

1. The proposed tariff sheets filed on November 23, 2020, by Evergy Metro, Inc., and assigned Tariff No. YE-2021-0122 are approved to become effective on January 18, 2021.
2. This order shall be effective on January 18, 2021.
3. This file shall close on January 19, 2021.
