On December 11, 2020, Staff filed its Recommendation. Ameren Missouri responded on December 18, 2020, stating it no longer needed the requested variances.

On December 21, 2020, the Commission allowed parties until December 28, 2020 to state why the Commission should not dismiss the application and close the file. The Commission received no responses.

The Commission will dismiss the application as moot, and will close the file.
