## ORDER GRANTING MOTION TO STAY

Issue Date: August 15, 2025

Effective Date: August 15, 2025

On July 16, 2025,<sup>1</sup> Complainant Bobby J. Armour filed a formal complaint against Spire Missouri Inc. d/b/a Spire. On July 17, the Commission ordered Staff's investigation be completed and a report filed by August 29. On August 6, the Staff of the Commission filed a *Motion to Stay/Suspend the Order for Investigation* (Motion) due to similarities in the current case and multiple previous filings.<sup>2</sup> The Commission then scheduled a procedural conference for August 20, but inadvertently did not rule on Staff's Motion.

The Commission finds this request reasonable and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's Motion is granted.
2. The Commission order for Staff to investigate and file a report by August 29, 2025 is suspended.
3. The Commission will order a new deadline for Staff to investigate and file a report after the procedural conference.
