Grain Belt Express hereby states as follows:

1. On May 21, 2025, Grain Belt Express filed its Response, addressing the additional arguments made in Ms. Meadows’ March 21, 2025 *Reply to Grain Belt Express LLC’s Motion for Reconsideration*. Attached to Grain Belt Express’ Response was an annotated timeline designated as Exhibit A, and supporting documents for the timeline were attached as Exhibits B-P.
