NOTICE AND RESPONSE TO FILINGS

On July 2, 2025, Jonathan Miller filed a complaint before the Commission. On August 18, 2025, the Complainant filed a request for equal access to the Commission's Electronic Filing and Information System (EFIS) stating that he has been denied a professional account and access to answers to Data Requests. Thereafter, the Complainant filed 62 documents regarding his access to EFIS. According to the Commission's records, the Complainant's account has a professional account designation in EFIS and the Complainant has equal access. The Commission notes that answers to Data Requests are sent to the party who requested them. If those answers are to Data Requests from Staff and are properly submitted in EFIS, an automatic notice from EFIS is sent only to the requesting party and not to all parties to the case.

In addition, the Complainant published the names of citizens who are not parties without permission by filing those documents in EFIS. Those filings are irrelevant to the Complaint. The Commission will delete those filings from EFIS.

The Commission directs the Complainant to the provisions governing procedures before the Commission, which are found at Commission Rule 20 CSR 4240-2, et seq. The Commission will also direct the Complainant to the booklet, "How to Present Your Formal Complaint Before the Commission," found on the Commission's public website. The Commission will further delete filings 41 thru 101 and any filings which are irrelevant and contain the names of persons Mr. Miller does not represent, as it is noted at 20 CSR 4240-2.070(7) that the Commission may strike irrelevant allegations.

THE COMMISSION ORDERS THAT:

- 1. The Commission will delete all filings which are irrelevant and filings with the names of citizens Mr. Miller does not represent.
- 2. The Commission directs the Complainant to review the booklet, "How to Present Your Formal Complaint Before the Commission."
- 3. The Commission directs the Complainant to review the requirements governing discovery proceedings found at Rule 20 CSR 4240-2.090.
 - 4. The Commission will delete filings 41 thru 101 from EFIS.
- 5. The Commission asserts that all EFIS access is equal as to the parties and EFIS is functioning appropriately.
 - 6. This order shall be effective when issued.
